1. National Water & Sewerage Corporation (NWSC) has allocated funds from its annual budget for the financial year 2015/2016 to be used for the acquisition of **Total Station-Surveying Equipments for Gulu, Mbarara and Mbale Areas.**
2. The NWSC therefore invites sealed bids from eligible bidders for the provision of **Total Station- Surveying equipment.**
3. Bidding will be conducted in accordance with the Open Domestic Bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2004, of Government of Uganda. This invitation is open to all eligible bidders.
4. Interested eligible bidders may obtain further information from and inspect the bidding documents at the address given below at 7(a) from 8:00 a.m. to 5:00 p.m. on working days.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application and obtaining a payment advice slip from the address below at 8(b) and upon payment of a non-refundable fee of **UGX 150,000** in cash to a Local Bank. The document should be collected by the prospective bidder or his representative. No liability will be accepted for loss or late delivery.
6. There shall be a pre – bid meeting at the address below at 8 (c) on July 19, 2016 at **11:00am.**
7. Bids must be delivered to the address below at 8(c) at or before 10:30 am East African Time on August 12, 2016. All bids must be accompanied by the following bid security of **UGX 4,000,000** or its equivalent in a freely convertible currency.

Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 11:00am East African Time on August 12, 2016.
