3. Bidding will be conducted in accordance with the Open Domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders in eligible source countries
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00AM to 5:00PM working days.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 300,000**. The method of payment will be cash at any local Bank. No liability will be accepted for loss or late delivery.
6. Bids must be delivered to the address below at 8(c) **before 10:30 East African time on 23rd August 2016**. All bids must be accompanied by a bid security of **UGX 100,000,000** or an equivalent amount in a freely convertible currency. The Bid security must be valid until **13th March 2017**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:00 AM East African time on 23rd August 2016**.
7. There shall be a pre – bid/Site visit meeting at **Kacung in Dokolo (approximately 40 KM on Lira –Soroti Road) at 11:00AM East African time on 21st July 2016**.
