National Water and Sewerage Corporation invites sealed bids from eligible bidders for the Construction of the NWSC Lira Offices located at Plots Nos.10/12 on Maruzi Rd & Nos. 13/14 on Tino Close, Lira; Lira Municipality, Lira District, Uganda. The scope of work includes; earthworks, excavations, foundation works, concrete-works, walling, roofing, shuttering, electromechanical works, internal and external finishes for the office block, the workshop and the security control unit as well as the external works.
3. Bidding will be conducted in accordance with the Open Domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders in eligible source countries

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of UGX 150,000. The method of payment will be cash at any local Bank. No liability will be accepted for loss or late delivery.

All bids must be accompanied by a bid security of **UGX 10,000,000** or an equivalent amount in a freely convertible currency. The Bid security must be valid until **March 06, 2017**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:00 AM East African time on August 16, 2015**
