1. The National Water & Sewerage Corporation (NWSC) has allocated funds from its annual budget for the financial year 2016/17 to be used for the acquisition of Aluminium Sulphate under a framework contract for eighteen (18) months.
2. The NWSC therefore invites sealed bids from eligible bidders, for the supply and delivery of Aluminium Sulphate under the lots below, under a framework contract arrangement.

3. Bidding will be conducted in accordance with the Open International Bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 of the Government of Uganda. This invitation is open to all bidders from eligible source countries.

A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application and obtaining a payment advice slip from the address below at 8 (b) and upon payment of a non-refundable fee of UGX 200,000/= or its equivalent in a freely convertible currency to a local Bank. The document should be collected by the prospective bidder or his representative. No liability will be accepted for loss or late delivery.
