



## **Standard Invitation to Bidders**

### **BID NOTICE UNDER OPEN INTERNATIONAL BIDDING**

**Subject of Procurement: Supply of 702,000 Kgs of liquid chlorine gas under framework contract for 18 months**

1. The National Water & Sewerage Corporation has allocated/received funds from its annual budget to be used for the acquisition of 702,000 Kgs of liquid chlorine gas under framework contract for 18 months. The requirement is categorised in two Lots as below;

**Lot 1:** Liquid chlorine gas to be supplied in the provider's cylinders

**Lot 2:** Liquid chlorine gas to be supplied in NWSC's cylinders

2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all eligible bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents during working days at the address given below at 8(a) from 8:00AM to 5:00PM.
5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(a) and upon payment of a non-refundable fee of UGX 200,000. The method of payment will be cash at any local Bank.
6. Bids must be delivered to the address below at 8(a) at or before **10:00AM East African time on November 02, 2016**. All bids must be accompanied by a bid security amounting to:

**Lot 1: UGX 20,080,000**

**Lot 2: UGX 20,080,000**

**or** an equivalent amount in a freely convertible currency and in the form of a Bank guarantee issued by a Bank located in Uganda or a foreign Bank through correspondence with a Bank located in Uganda. Late delivery of bids shall be rejected and no liability will be accepted. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(a) **10:00 AM East African time on November 02, 2016**
