1. The National Water & Sewerage Corporation (NWSC) has allocated funds from its annual budget for the financial year 2015/16 to be used for the acquisition of assorted PE & PVC pipes under a framework contract for eighteen (18) months
2. The NWSC therefore invites sealed bids from eligible bidders, for the supply and delivery of assorted PE & PVC pipes detailed under lots below under a frame work contract arrangement.

Lot 2: Assorted HDPE pipes for Mains Extensions
Lot 3: Assorted HDPE pipes for New Connections
3. Bidding will be conducted in accordance with the Open Domestic Bidding procedures contained in the Public Procurement and Disposal of Public Assets Act, 2003 of the Government of Uganda. This invitation is open to all bidders from eligible source countries.

The document should be collected by the prospective bidder or his representative. No liability will be accepted for loss or late delivery.
