1. National Water and Sewerage Corporation has allocated funds to be used for the Construction of Water Treatment Units to augment water production in the Masindi Water Treatment Plant at Kiyanja, Masindi District.
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00am to 5:00pm on working days.
5. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **Ug. Shs. 150,000** in cash to a Local Bank. The document should be collected by the prospective bidder or his representative. No liability will be accepted for loss or late delivery.
6. Bids must be delivered to the address below at 8(c) at or before 10:00am on **April 17, 2015**. All bids must be accompanied by a bid security of **UGX 10,000,000** or an equivalent amount in a freely convertible currency. Bid securities must be valid until **October 17, 2015**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 10:30am on **April 17, 2015**.
7. There shall be a pre-bid meeting/site visit at **the NWSC Masindi Area Office, in Masindi District, starting at 10:00am on March 31, 2015**.
