3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 and is open to all bidders.

The document should be collected by the prospective bidder or his representative. No liability will be accepted for loss or late delivery.

All bids must be accompanied by a bid security of **UGX 20,000,000** or an equivalent amount in a freely convertible currency. Bid securities must be valid until **September 30, 2015**.
